GENERAL OBSERVATIONS OF THE AUDIT COMMITTEE:

- Established in 1942, Ananda Chandra College is one of the prime colleges of Jalpaiguri.
- 2. The college is affiliated to North Bengal University
- 3. The college completed 2nd cycle of NAAC accreditation with a CGPA of 2.88 and obtained B++ grade. The college is preparing for 3rd cycle.
- 4. The college offers 20 UG Programmes of which 18 have Honours Courses and 2 Programme Courses, and 1 PG Programme course.
- 5. The Management & the Principal have a progressive vision with a definite plan of action following a decentralised administrative network.
- 6. A substantial number of faculty members with a mix of newly appointed and experienced:
- Total faculty: 125 of which 22 are Associate Professors, 35 are Assistant Professors and 68 are SACT.
- 7. Total Faculty members with Ph.D are 33.
- 8. For the session 2022-23, percentage of student enrolment is 79.4%
- 9. With regard to student admission the college complies with the reservation policies for admission set by the Government of West Bengal.
- 10. Departments function in alignment with the institutional quality policies.
- 11. The College has an active IQAC which holds meetings at regular intervals.

12. The college runs from its own building and has a large campus with sufficient greenery.

SPECIFIC OBSERVATIONS AND SUGGESTIONS:

A) Curricular Aspects:

- i. The college prepares and maintains an Academic calendar.
- ii. Before the commencement of classes in each semester, the syllabus is distributed, as decided in Departmental meeting, among the teachers in each Department.
- iii. Teachers prepare a teaching plan/lesson plan at the commencement of the session and follow it.
- iv. The curriculum is designed by North Bengal University; however, some of the teachers of the college are involved in designing and development of curriculum as members of BOS.
- v. The teachers submit academic report to the Principal.
- vi. Feedback is collected and analysed with proper directions from IQAC. Feedback report is displayed in Institutional website.
- vii. During Academic year 2022-23, one Add-on course "Drama in Practice" following the guidelines of UGC was jointly conducted by Department of Bengali and English. Other departments are suggested to conduct such courses.
- viii. Departments are suggested to encourage their students to enroll themselves in online courses of MOOCs, SWAYAM etc.
- ix. Relevance of cross cutting issues should be categorised separately with specific mention.
- x. Some of the departments conducted field works.

B) Teaching-Learning and Evaluation:

- i) Student-centric methods such as preparing project reports, film and documentary screening, study visits and tours etc. are effectively used.
- ii) Remedial Teaching Scheme and mentoring system are implemented but documentation should be improved.
- iii) Student evaluation is transparent and Continuous Assessment Process is implemented. Progress of students is monitored by conducting continuous internal assessment.
- iv) Student-teacher ratio is satisfactory.
- v) Pass Percentage of B.A. / B.Sc Honours and M.A. students is quite satisfactory but that of B.A. Programme course is a matter of concern.
- vi) Attainment of POs and COs should be documented.
- vii) Implementation of ICT tools in teaching-learning process needs improvement.

C) Research, Innovations & Extension

- i) 33 Teachers are Ph.D degree holders, some of whom are actively involved in research. Some of the teachers are pursuing Ph.D.
- ii) 5 of the teachers are acting as research guide.
- iii) Faculty members published papers in UCC listed journals/edited books and authored books; however, given the total number of teachers, the publications of faculty should be improved.
- iv) No Research project is sanctioned during the year. It needs major improvement.
- v) The number of webinar/workshop/special lectures conducted during the year is not quite satisfactory.
- vi) In conducting extension and outreach programmes, NCC/NSS are quite active.

- vii) Sensitization programmes involving students in identified communities should be systematically organised.
- viii) No. of MoUs signed during the year is 5. More MoUs should be signed for formalizing faculty/student exchange and collaborative research.

D) Infrastructure, Learning Resources and Library

- Amidst space constraints, it was noted that sufficient care is being taken to accommodate all required facilities. Some of the science departments have shifted to the newly constructed Science Building.
- ii) The college has an Open theatre, a Seminar Hall, Gymnasium and a large playground facilitating students to engage in extra-curricular activities. Quality maintenance of these facilities should be prioritized.
- iii) Staff rooms/ work environment of certain departments have to be augmented.
- iv) Quality maintenance of lab facilities in most of the departments should be a major priority. Quality of equipment and cleanliness must be given more attention.
- v) Good and adequate facilities are given for the physically challenged.
- vi) ICT facilities need improvement. Computer-student ratio is around 72: 1 which should be improved.
- vii) With the commencement of off-line classes, the departments should be provided with sufficient bandwidth for internet connection.
- viii) The College library is automated. The overall ambience of the library is good. Appreciable efforts are taken to provide a better ambience for reading.
- ix) The library has subscription of N-List (INFLIBNET). The number of offline Journals and magazines subscribed by the Central library are 9 and 8 respectively.

- x) The database of the central Library has been switched over from SOUL to KOHA 22.11.03 version during this academic session.
- xi) A library committee exists. The implementation of library policy is monitored.
- xii) Usage of library by the faculty members and students should improve.
- xiii) The library-centred activities like observation of library week and the individual awards instituted for the best library user among staff and students should be introduced.

E) Student Support & Progression

- There are a good number of beneficiaries of Government Scholarships and Institutional Scholarships.
- ii) The college has an active Career Guidance Cell which organises programmes for college students time to time. Career counselling must be intensified to improve the attainment in competitive exams.
- iii) Active Grievance Redressed cell to sort out the student's problem.
- iv) Anti-ragging cell and ICC are active.
- v) Commemorative days of national and international importance were celebrated. Several cultural programmes were organised at the Departmental level as well as at the Institutional level thoughout the year.
- vi) Reading Club, Film Clubs for students are active. More Clubs such as Eco Club, Electoral Club should be formed for holistic development of the students.

F) Governance, Leadership & Management

i) Vision and Mission of the Institution is followed all through the planning.

- ii) The College decentralizes curricular, cocurricular and extra cocurricular activities through various committees.
- iii) The Sub-committees and Statutory committees are functional in meeting the academic and non-academic requirements of the students.
- iv) IQAC is functional. It takes initiative in quality enhancement activities.
- v) IQAC holds meetings.
- vi) AQAR is not submitted timely. IQAC should be more active in timely submission of AQAR.
- vii) Duty leave is provided to teachers to encourage them to undertake various academic activities.
- viii) Self-appraisal system of teacher for better performance at the end of every year exists. The college has introduced appraisal system for Nonteaching staff.
- ix) Training to administrative staff should be given in strengthening egovernance. More training shall be given to improve the IT skills of the administrative staff.
- x) Sufficient welfare measures are provided to the staff.
- xi) PBAS are processed effectively.
- xii) Fund mobilisation cell should be strengthened. An effective fund mobilisation cell may be formed.

G) Institutional Values & Best Practices

- i) The College is resorting to a green campus concept.
- ii) The campus is surrounded by a large number of trees and has a medicinal plant garden.
- iii) Rainwater harvesting has been maintained properly
- iv) The college has taken some initiatives to improve its solid waste management but it needs more improvement.
- v) Green/ energy audits for the academic year 2022-23 have been done.

- vi) Sufficient information has to be conveyed to students and staff regarding important days observed, national obligations, human rights, values etc. through the general display system of the campus.
- vii) More emphasis should be given to the Institutional Best practices by all the departments.

H) Documentation

- i) There should be a common institutional format for documentation regarding student participation and attendance list, Geo-tagging, and report of various events.
- ii) Although the departments maintain documents, effective updating should be monitored by IQAC.

I) SWOC Analysis

- > Experienced and dedicated teaching staff.
- Eco-friendly College building with sufficient and pleasant learning environment.

- ➤ Departments function in alignment with the institutional quality policies.
- Large number of books available in library

Weakness:

- ➤ The number of publications is small as compared to the number of full-time teachers.
- Minor and Major research project sanctioned in the college is nil.
- Inadequate Laboratory facilities/instruments
- Inadequate ICT facilities for teaching-learning
- Inadequate waste management system.

Opportunities:

- Faculty enrichment through online courses like Swayam, NPTEL
- Strengthening collaboration with research institutes and Industries
- ➤ Increasing research publications in high impact factor journals.
- Scope for starting skill-oriented courses.

Challenges:

- Own fund mobilisation
- Increasing student-computer ratio
- To enhance Linkage and collaboration with Industries and research institutes.

GENERAL RECOMMENDATION OF THE AUDIT COMMITTEE:

- There should be an overall enhancement of quality in personal, professional,
 Infrastructure, student outcome and administration.
- 2. Teachers should take up more research projects. Publications by the Faculty members should increase. A research culture should prevail in the campus.
- More MoUs should be signed by the colleges. Quality exposure of teachers is very much recommended. Research collaborations and faculty exchange should be promoted.
- 4. More seminar and workshops are to be organised.
- 5. Skill development activities for the students have to be promoted.
- 6. The departments should introduce more Add-on and Certificate courses following UGC guidelines.

- 7. The library should have inadequate subscription of UGC listed reputed journals with good impact factors. Departments need to establish its own library.
- 8. More classrooms should have ICT tools for effective curriculum delivery.

 Maintenance of physical facilities should be augmented.
- 9. Waste management system should be improved.
- 10. IQAC is the quality command centre of the campus and therefore should give appropriate functional directives.
- 11. IQAC should take initiatives to submit pending AQARs within time.
- 12. There should be a common institutional format for documentation.
