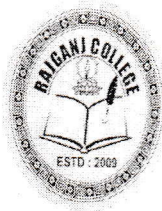

SPECIAL PROVISIONS :


1. Each party will take approval from the other party in writing prior to using the letter's name and logo for the activities here under on a case basis.




