Any additions, changes or deletion to this document must be approved by the representatives of both. All notices shall be in writing and shall be directed to these representatives.

**NON-EXCLUSIVITY:**

This agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreement with third parties.

**SPECIAL PROVISIONS:**

1. Each party will take approval from the other party in writing prior to using the latter's name and logo for the activities here under on a case by case basis.
2. Neither party can misuse this MoU by involving the name of the other without the written consent from the other party.
3. There will be no financial involvement by either of the Party.

**DISPUTES:**

If any disputes arise in respect of the MoU, in that case both the organisation will discuss and settle the matter amicably.
