The Memorandum of Understanding (MoU) has come into effect from 2023-24 Session to establish an agreement between HAZI A.K. KHAN COLLEGE, Hariharpara, a West Bengal Government Aided Undergraduate Degree College with its office at Hariharpara PS- Hariharpara, Dist – Murshidabad, WB, Pin-742166, established in 2008 affiliated to University of Kalyani, hereinafter referred to as HAZI A. K. KHAN COLLEGE and represented by its principal, referred to as FIRST PARTY, for the purpose of exchange of students, faculties and faculties of Central Library.

AND

ANANDA CHANDRA COLLEGE, a West Bengal Government Aided Undergraduate Degree College with its office at College Para P.O.+District Jalpaiguri, WB, Pin-735101, India, established in 1942, affiliated to University of North Bengal hereinafter referred to as ANANDA CHANDRA COLLEGE and represented by its Principal, referred to as SECOND PARTY, for the aforesaid purpose.

The aforesaid institutions are hereinafter referred to individually/collectively as college/colleges.

PREAMBLE

Whereas, HAZI A K KHAN COLLEGE and ANANDA CHANDRA COLLEGE have many areas of common interest in Arts and some non-academic activities, considerable advantage may be gained from their pursuit for academic and environment related excellences on a collaborative basis in the fields of academics, pedagogy and research and nature

Now therefore, HAZI A K KHAN COLLEGE and ANANDA CHANDRA COLLEGE have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutions in the following sections.

ARTICLE 1: OBJECTIVE

To develop the following collaborative activities in the academic areas of mutual interest, on the basis of equality and reciprocity, the two institutions shall seek to promote:

A. Faculty/Staff exchanges

A. Faculty/Staff exchanges

Both the institutions will promote:

Exchange of faculty members and the faculties/staff of Central Library i.

- Collaboration in research and development, and consultancy studies in the field of mutual interest related to ii. Central Library and other departments. iii.
- Exchange of academic materials and publications in the field mentioned.
- iv. Conduction of lectures by resource person in related fields.
- Joint research activities wherever feasible in aforesaid subjects. V.
- Participating in seminars, workshops, symposia, other kinds of academic discussions. vi.
- Conduction of institutional visit and joint consultancy work wherever feasible. vii.

A specific plan will be worked out for each activity and detailed arrangements for such collaborative work will be agreed upon

B. Student Exchange

- a) Students exchange programme will be conducted on mutual understanding between two colleges.
- b) Exchanged students may be evaluated by the host institution if such an evaluative framework for the academic interest of students be worked out. This will in no way impede or influence her/his evaluation in own college or university assessment/ evaluation.

C. Other areas

- a) To explore the provision of cultural and intellectual enrichment opportunities for staff, faculty and students of both the institutes.
- b) To promote and explore digital Library Services.

HAZI A K KHAN COLLEGE and ANANDA CHANDRA COLLEGE have agreed that detailed terms and conditions that guide each activity identified above will be determined separately and have also agreed upon by the two colleges. These terms will include a technical description of the proposed activity, financial arrangements and person(s) responsible for

ARTICLE 2: COORDINATION

Each college shall appoint one member of its teaching faculty to coordinate & fast track the programme on behalf of the Head of the Institution of each college. Further, a Coordination Committee consisting of two Heads of the Institution and the two Coordinators will periodically (once a year) reviews and identify ways to strengthen cooperation between two

ARTICLE 3 CONFIDENTIAL INFORMATION

The two colleges will retain and respect individual confidentiality, including those pertaining to the collaborative activities of both the colleges.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including confidential information, know-how, patents, copyrights, design rights, rights relating to computer software and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested on both the colleges in this MoU. Both the colleges shall have right to determine the commercial implications, disposition and exploitation of such intellectual property and shall make joint applications for the registration of the same. Any publication regarding such intellectual property shall only be possible with prior written consent of both the colleges.

ARTICLES 5: VALIDITY

Initially, the MoU shall remain in force for a period of three (03) years commencing from the date of effect, the Institutions may extend the term by written agreement signed by both the authorities after review.

ARTICLE 6: TERMINATION

Termination of this MOU is subject to prior notification of 1 (one) month from any of these Institutions.

ARTICLE 7: LEGAL EFFECT

Nothing in this MoU shall be construed as creating any legal relationship between the two colleges. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

ARTICLE 8: DISPUTE RESOLUTION

In case of a dispute relating to any aspect of academic cooperation, Head of the Institutions of both the colleges will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.

HAZI A K KHAN COLLEGE and ANANDA CHANDRA COLLEGE welcome the signing of this Memorandum of cooperation and jointly agree to the provisions set out as above.
